SELF-EXAMINATION OF BUDGET RESOLUTION [As required by DCA]

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Town of Hammonton has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2021 budget year.

- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
 - 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated.

- b. Items of appropriation are properly set forth,
- c. In itemization, form, arrangement and content, the budget will Permit the exercise of the comptroller function within the municipality.
- 5. The budget has been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.

Introduction of Ordinance #006-2021- Approval to Establish a CAP Bank

COUNTY OF ATLANTIC CALENDAR YEAR 2021 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 1.0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Town Council of the Town of Hammonton in the County of Atlantic finds it advisable and necessary to increase its CY 2021 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Town Council hereby determines that a 2.5% increase in the budget for said year, amounting to \$ 260,333.59 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Town Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Town Council of the Town of Hammonton, in the County of Atlantic, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2021 budget year, the final appropriations of the Town of Hammonton shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$364,467.03, and that the CY 2021 municipal budget for the Town of Hammonton be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Public Hearing of Ordinance #004-2021- Cannabis Geographical Boundaries

AN ORDINANCE OF THE TOWN OF HAMMONTON, COUNTY OF ATLANTIC, STATE OF NEW JERSEY PROHIBITING THE OPERATION OF ANY CLASS OF CANNABIS BUSINESSES WITHIN ITS GEOGRAPHICAL BOUNDARIES AND AMENDING CHAPTER 175, ARTICLE XIII OF THE LAND DEVELOPMENT ORDINANCES OF THE TOWN OF HAMMONTON

WHEREAS, in 2020 New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS, the Act establishes six marketplace classes of licensed businesses, including:

- Class 1 Cannabis Cultivator license, for facilities involved in growing and cultivating cannabis;
- Class 2 Cannabis Manufacturer license, for facilities involved in the manufacturing, preparation, and packaging of cannabis items;
- Class 3 Cannabis Wholesaler license, for facilities involved in obtaining and selling cannabis items for later resale by other licensees;
- Class 4 Cannabis Distributer license, for businesses involved in transporting cannabis plants in bulk from on licensed cultivator to another licensed cultivator, or cannabis items in bulk from any type of licensed cannabis business to another;

- Class 5 Cannabis Retailer license for locations at which cannabis items and related supplies are sold to consumers; and,
- Class 6 Cannabis Delivery license, for businesses providing courier services for consumer
 purchases that are fulfilled by a licensed cannabis retailer in order to make deliveries of the
 purchases items to a consumer, and which service would include the ability of a consumer to
 make a purchase directly through the cannabis delivery service which would be presented by
 the delivery service for fulfillment by a retailer and then delivered to a consumer.

WHEREAS, section 31a of the Act authorizes municipalities by ordinance to adopt regulations governing the number of cannabis establishments (defined in section 3 of the Act as "a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer"), cannabis distributors or cannabis delivery services allowed to operate within their boundaries, as well as the location manner and times operation of such establishments, distributors or delivery services, and establishing civil penalties for the violation of any such regulations; and

WHEREAS, section 31b of the Act authorizes municipalities by ordinance to prohibit the operation of any one or more classes of cannabis establishments, distributors, or delivery services anywhere in the municipality; and

WHEREAS, section 31b of the Act also stipulates, however, that any municipal regulation or prohibition must be adopted within 180 days of the effective date of the Act (i.e., by August 22, 2021); and

WHEREAS, pursuant to section 31b of the Act, the failure to do so shall mean that for a period of five years thereafter, the growing, cultivating, manufacturing, selling and reselling of cannabis and cannabis items shall be permitted uses in all industrial zones, and the retail selling of cannabis items to consumers shall be a conditional use in all commercial and retail zones; and

WHEREAS, at the conclusion of the initial and any subsequent five-year period following a failure to enact local regulations or prohibitions, the municipality shall again have 180 days to adopt an ordinance regulating or prohibiting cannabis businesses, but any such ordinance would be prospective only and would not apply to any cannabis business already operating within the municipality; and

WHEREAS, Town Council of the Town of Hammonton has determined that, due to present uncertainties regarding the potential future impacts that allowing one or more classes of cannabis business might have on New Jersey municipalities in general, and on Hammonton in particular, it is at this time necessary and appropriate, and in the best interest of the health, safety and welfare of Hammonton's residents and members of the public who visit, travel, or conduct business in the Town of Hammonton to amend Hammonton's zoning regulations to prohibit all manner of marijuana-related land use and development within the geographic boundaries of the Town of Hammonton; and

WHEREAS, officials from two prominent non-profit organizations that have been established for the purpose of advising New Jersey municipalities on legal matters such as have been presented by the Act (those organizations being the New Jersey State League of Municipalities and the New Jersey Institute of Local Government Attorneys) have strongly urged that, due to the complexity and novelty of the Act; the many areas of municipal law that are or may be implicated in decisions as to whether or to what extent cannabis or medical cannabis should be permitted for land use purposes or otherwise regulated in any particular municipality; and the relatively short duration in which the Act would allow such decisions to be made before imposing an automatic authorization of such uses in specified zoning districts subject to unspecified conditions, the most prudent course of action for all municipalities, whether or not generally in favor of cannabis or medical cannabis land development and uses, would be to prohibit all such uses within the Act's 180-day period in order to ensure sufficient time to carefully review all aspects of the Act and its impacts.

NOW THEREFORE, BE IT ORDAINED, by Town Council of the Town of Hammonton in the County of Atlantic, State of New Jersey, as follows:

- 1. Pursuant to section 31b of the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (P.L. 2021, c. 16), all cannabis establishments, cannabis distributors or cannabis delivery services are hereby prohibited from operating anywhere in the Town of Hammonton except for the delivery of cannabis items and related supplies by a delivery service.
 - 2. Chapter 175, Article XIII, Section 145, a Subsection M is added which reads as follows:
 - M. Cannabis. All classes of cannabis establishments, cannabis distributors or cannabis delivery services as said terms are defined in the New Jersey Cannabis Regulatory, Enforcement Assistance and Marketplace Modernization Act (P.L. 2021, c. 16), are hereby prohibited within the Town of Hammonton, except for the delivery of cannabis items and related supplies by a licensed cannabis delivery service.

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the Courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any Ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect following adoption and approval in the time and manner prescribed by law.

Public Hearing of Ordinance #005- 2021- Mullica Joint Municipal Court

AN ORDINANCE OF THE TOWN OF HAMMONTON ESTABLISHING A SINGLE JOINT MUNICIPAL COURT WITH MULLICA TOWNSHIP AND AMENDING CHAPTER 14, ARTICLE I OF THE GENERAL ORDINANCES OF THE TOWN OF HAMMONTON

WHEREAS, N.J.S.A. 2B:12-1(b) authorizes the formation of a single Joint Municipal Court provided that an Agreement is entered into by the Town of Hammonton and Mullica Township and provided that the Agreement is filed with the State of New Jersey Administrative Director of the Courts and the Assignment Judge of the Superior Court of New Jersey, Atlantic County; and

WHEREAS, the Town of Hammonton desires to enter into an Agreement to form a Joint Municipal Court with Mullica Township; and

WHEREAS, it is in the best interest of the Town of Hammonton to participate in the Joint Municipal Court with Mullica Township.

NOW, THEREFORE, BE IT ORDAINED by Council of the Town of Hammonton, County of Atlantic, State of New Jersey, as follows;

Chapter 14, Article I, Section 1 is amended to read as follows:

§14-1. Establishment.

A Joint Municipal Court is established, pursuant to the provisions of N.J.S.A. 2B:12-1, et. seq., as amended and supplemented, consisting of the Town of Hammonton, Borough of Folsom, Egg Harbor City, Buena Vista Township and Mullica Township. The Joint Municipal Court with Folsom was created in accordance with an Agreement for a Joint Municipal Court for the Municipalities of the Town of Hammonton and the Borough of Folsom dated December 28, 2017, executed by the municipalities in January of 2018, and First Addendum to the Agreement dated September 19, 2019, fully executed on December 3, 2019, and is subject to the terms thereof. The Joint Municipal Court with Egg Harbor City was created in accordance with an Agreement for Joint Municipal Court for the Municipalities of the Town of Hammonton and Egg Harbor City dated January 2, 2020, and executed in January of 2020, and is subject to the terms thereof. The Joint Municipal Court with Buena Vista Township was created in accordance with an Agreement for Joint Municipal Court for the Municipalities of the Town of Hammonton and Buena Vista Township dated August 24, 2020 and executed in August 2020. Mullica Township shall join the Joint Municipal Court of the Town of Hammonton in accordance with an Agreement for a Joint Municipal Court for the Municipalities of the Town of Hammonton and Mullica Township dated April 26, 2021, and executed in May of 2021.

The terms and conditions of the Agreement for a Joint Municipal Court for the Municipalities of the Town of Hammonton and Mullica Township dated April 26, 2021, are hereby approved. The Mayor and Clerk for the Town of Hammonton are hereby expressly authorized to execute and deliver the aforesaid Agreement on behalf of the Town.

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the Courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any Ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect following adoption and approval in the time and manner prescribed by law.

ENGINEER REPORT

ACTION ITEMS:

1. Lake Park ADA Playground/Small Cities (ARH Propsal#21-0230):

As previously reported, ARH was requested to prepare a proposal to complete the design, permitting and construction oversight for a new playground area at the Lake Park. The project is funded in part by Small Cities and will have a focus on ADA features. Currently, we have prepared a proposal for the Town's consideration. Introduction of Ordinance # 008-2021- Amending Chapter 175 Accessory Structures

AN ORDINANCE TO AMEND CHAPTER 175 OF THE GENERAL ORDINANCES OF THE TOWN OF HAMMONTON

BE IT ORDAINED by the Mayor and Council of the Town of Hammonton, County of Atlantic and State of New Jersey as follows:

1. Chapter 175, Section 175-87(D) is amended to add the following sentence to the end of the Section:

If an accessory structure is erected in the side yard, it must be setback a minimum of 5 feet behind the front facade of the principle building.

- 2. Chapter 175, a Section 175-87(F) is added which states as follows:
 - F. Square footage. In no case shall the total cumulative area of all accessory structures exceed the following square footages:
 - (1) FA, AP, and AP/CLI Zoning Districts-1,500 Square Feet;
 - (2) RR Zoning District- 1,000 Square Feet;
 - (3) R3 Zoning District 500 Square Feet; and
 - (4) RI and R2 Zoning Districts 400 Square Feet.

Notwithstanding the above, Agricultural uses on qualified farms are not subject to the size restriction set forth in this Section 175-87(F), provided the accessory structure is to be utilized for the farming/agricultural operation. For purposes of this Section 175-87(F), the term "qualified farms" shall mean those farms that are a minimum size of 5 acres and meet the farmland assessment criteria.

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the Courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any Ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

PWM REPORT

Radon Awareness Program, Test Kits

As a reminder test kits, program information, etc. could be picked up by Hammonton residents at the Town Hall, 3rd Floor Clerk's Office during normal business hours.

Tree Delivery, Installation

Scott has planted all the trees at the Boyer Avenue Rec. Site and the 50 bare root trees along with the Salem Oak Seedling in the nursery behind their Public Works building. We applied to the NJDEP, Division of Parks and Forestry for reimbursement of funds expended for the project.

Safe Routes to Schools, Sooy Elementary School

We received a letter from the NJDOT that the Town's project forms were approved for the Federal Aid funding program allotment. We are waiting for the signed project funding agreement from the NJDOT. Once the signed agreement documents are received the Town could amend the budget to accept the funds and sign the project contract with GPI so they could start their work.

2022 Municipal Aid/Discretionary Aid

The NJDOT will be accepting applications for their 2022 Municipal Aid Program. Applications are due by July 1st. Any candidates for funding consideration must be selected. They will also be accepting applications for Bike Path extension and Safe Routes to Transit. ARH will provide a proposal for Council's approval to prepare the application, reports, estimates and mapping required for the program and candidates requested. Authorization to proceed would be appropriate with the issuance of the Purchase Order for same.

Storm Water Utility Program

Princeton Hydro has set a date of Wednesday, 5/26 between 6 p.m. to 8 p.m. for the steering committee meeting consisting of Town residents, Committee members and Town personnel. This committee will provide input related to the Town's drainage needs and discuss means for possible program funding to achieve identified goals. The work completed by Princeton Hydro is being funded by a grant from the New Jersey League of Conservation Voters.

Drainage Projects

The Public Works chairman and Department have been working on a list of drainage projects that need attention throughout the Town. If deemed acceptable, the project funding could be established in the 2021 municipal budget.

Rt. #54 NJDOT meeting

Representatives from the Town met onsite with NJDOT officials to discuss various topics on the Rt. #54 resurfacing project, along with drainage investigative work and possible cleaning efforts for Cedar Brook (Branch) Stream corridor. A listing of roadway sections needing repair was also provided to the NJDOT. We have also contacted the County about a possible shared services agreement for the stream corridor.

Rt. #54 Water Main Replacement

The Town will be exploring the use of the NJ I-Bank Program funds to secure a commitment (low interest loans) to provide for the replacement of the old 6" water main on 12th Street, Rt. #54 between 1st Road and 2nd Road prior to the NJDOT resurfacing that roadway. ARH has prepared a construction estimate and a proposal to Council to complete the field work and design for the project. They have also investigated other water replacement needs as discussed with the Municipal Utilities Department Superintendent and Committee Chairperson.

Pedestrian/Bicycle Master Plan Report

Sam Schwartz consultant for the Town is completing the final version of the report for presentation to the Town once the State approves the current version of their report. The funds for the study and report were obtained from the NJDOT. Some additional comments received from Town residents were also provided to the consultant for comment and possible inclusion within the report.

Various Park and Public Works Projects

The Town received information from the State and other program groups about potential funding options for various projects. We will discuss these options with applicable Town Committees and Triad to decide which programs might be advantageous for the Town to pursue.

Bellevue Avenue Parklets and Crosswalks

A letter was sent to Vanessa Meades from the NJDOT regarding the guidelines for establishment of parklets within the downtown area along with the possibility for the placement of new painted crosswalks at the downtown intersections along Rt. #54. Any information received will be shared with the downtown representatives and Council.

Electric Vehicle Charging Station, Vine Street Parking Lot

The Town has received notice from the State for approval of a grant in the amount of \$8,000 maximum for the installation of a dual port electrical vehicle charging station within the Vine Street parking lot across from Town Hall. The Town must wait for the agreement from the State before proceeding with the project. \$17,500 was

originally requested in the application for funding consideration. Any difference in the cost for project must be established with Town Budget for 2021. We have completed an application to Atlantic City Electric to supply an electric service to the site.

Sustainable N.J. Atlantic City Electric Grant

The Town is investigating possible projects that might be eligible for a \$2,000 to \$5,000 maximum grant from the Sustainable N.J. Atlantic City Electric grant program. We will be discussing possible projects with the appropriate Town committees.
