Stuart Wiser started the discussion with addressing the Board as their role in the Community also discussing the Boards powers and responsibilities to the Municipal Law as well as their community. The application process was discussed in detail for the Joint Land Use process. The start of the application process begins with the applicant submitting all necessary documents noted on the checklist provided to them for what they are applying for. Stuart Wiser and his office make sure that the application is deemed complete before going before the Board. Councilman Wuillermin questioned if the checklist and application were reasonable, Stuart Wiser replied that we are very fair and accommodating with what the applicant is responsible for providing. Also how this process has been working well. Michael Hozik brought to attention the need for an Environmental Impact Statement with the checklist and application when it is necessary. Joseph McGoarty was in agreement to this statement. Different Variances were also discussed and the purpose being to promote public safety and wellness. As well as provide sufficient space to promote a desirable visual environment. Stuart Wiser also stated that after the application is deemed complete the applicant will be placed on the agenda in 21 days from the date deemed complete. With that being said he stated he would like to follow that ordinance of 175-35.

Chairman Marinelli opened the meeting to the public. No one came forward. Closed to the public.
