- 3. Bernadette Rodio, 37 N. Packard. 1 tree, no replacement. Dead. Motion to approve: Caruso-Cafiso and Crowley, approved by acclamation, one abstention.
- 4. Jacqueline Bruno, 828 Central Avenue. 1 tree, no replacement. Damaged, diseased. Motion to approve: Caruso-Cafiso and Bethmann, approved by acclamation, one abstention.
- 5. Robert Gunst, 309 Orchard Street. 2 trees, no replacement. Roots lifting driveway and sidewalk. Motion to approve removal of tree by driveway, but recommending judicious crown reduction for backyard tree: Caruso-Cafiso and Crowley, approved by a=acclamation, one abstention.
- 6. JoAnne Silver, PO Box 53, Elwood. Trees located at 524 Grape Street. 1 tree, no replacement. Tree growing too large and unruly. Motion to approve: Bethmann and Caruso-Cafiso, approved 6-1, one abstention.
- 7. Ann C. Byers, 1029 N. 1st Road. 1 tree, 1 replacement. Dead. Motion to approve Caruso-Cafiso and Crowley, approved by acclamation, one abstention.
