WHEREAS, the Town Council of the Town of Hammonton, in the County of Atlantic, State of New Jersey (the "Town") heretofore finally adopted Bond Ordinance Number 22-2024 on December 16, 2024, entitled, "BOND ORDINANCE PROVIDING FOR THE PURCHASE OF PROPERTY, BY AND IN THE TOWN OF HAMMONTON, IN THE COUNTY OF ATLANTIC, STATE OF NEW JERSEY; APPROPRIATING \$694,000 THEREFOR (INCLUDING A GRANT FROM THE NEW JERSEY DEPARTMENT OF ECONOMIC DEVELOPMENT AUTHORITY) AND AUTHORIZING THE

ISSUANCE OF \$142,500 BONDS OR NOTES TO FINANCE PART OF THE COST THEREOF" (the "Original Bond Ordinance"); and

WHEREAS, the Town hereby seeks to repeal the Original Bond Ordinance and replace the Original Bond Ordinance with the following new bond ordinance.

NOW THERFORE, BE IT ORDAINED AND ENACTED BY THE TOWN COUNCIL OF THE TOWN OF HAMMONTON, IN THE COUNTY OF ATLANTIC, STATE OF NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

SECTION 1. The improvement or purpose described in Section 3 of this bond ordinance is hereby authorized as a general improvement or purpose to be undertaken by the Town. For the said improvement or purpose stated in Section 3, there is hereby appropriated the sum of \$150,000, said sum being inclusive of \$7,500 as the amount of down payment for said improvement or purpose as required by the Local Bond Law, N.J.S.A. §40A:2-1 et seq. (the "Local Bond Law"). Said down payment is now available by virtue of a provision or provisions in a previously adopted budget or budgets of the Town for down payment or for capital improvement purposes.

SECTION 2. For the financing of said improvement or purpose described in Section 3 hereof and to meet the part of said \$150,000 appropriation not provided for by the \$7,500 down payment, negotiable bonds of the Town are hereby authorized to be issued in the aggregate principal amount of \$142,500 pursuant to, and within the limitations prescribed by, the Local Bond Law. In anticipation of the issuance of said bonds and to temporarily finance said improvement or purpose, negotiable notes of the Town in an aggregate principal amount not exceeding \$142,500 are hereby authorized to be issued pursuant to, and within the limitations prescribed by, said Local Bond Law.

- **SECTION 3.** (a) The improvement hereby authorized and purpose for the financing of which said obligations are to be issued are for various improvements to the Municipal Building, including, as applicable, all work, materials, equipment, labor and appurtenances as necessary therefor or incidental thereto.
- (b) The estimated maximum amount of bonds or notes to be issued for said improvement or purpose is \$142,500.(c) The estimated cost of said improvement or purpose is \$150,000, the excess amount thereof over the said estimated maximum amount of bonds or notes to be issued therefor is the down payment for said improvement or purpose in the amount of \$7,500.

WHEREAS, a number of public entities in the State of New Jersey have joined together to form the NJ Solutions Joint Health Insurance Fund, hereafter referred to as the "Fund", as permitted by N.J.A.C. 11:15-3.1 ET. seg., N.J.S.A. 17:1-8.1 ET. seg. and N.J.S.A. 40A:10-36 et. seg., and

WHEREAS, the Fund was approved to become operational by the Department of Banking and Insurance and the Department of Community Affairs (collectively, the "<u>Departments</u>") and has been operational since that date; and

WHEREAS, the statutes and regulations governing the creation and operation of a joint insurance fund in the State of New Jersey contain certain restrictions and safeguards in connection with the administration of the public interest entrusted to such a Fund; and

WHEREAS, the governing body of Town of Hammonton, hereinafter referred to as "<u>Local Unit</u>" has studied the feasibility of joining the Fund and has determined that membership in the Fund is in the best interest of the Local Unit.

- **NOW, THEREFORE, BE IT RESOLVED** that the governing body of the Local Unit hereby agrees and authorizes the following:
 - i. Execution of the application for membership to the Fund, including all documents and/or certifications as may be necessary, in order for the Local Unit to complete the application process and join the Fund.
 - ii.The Local Unit shall become a member of the Fund for an initial period outlined in the Local Unit's Indemnity and Trust Agreement, subject to the approval of the Fund Commissioners, which in no event shall exceed three (3) years as prescribed in N.J.A.C. 11:15-3.3(a).
 - iii.The Local Unit shall participate in the following type(s) of coverage(s) offered by the Fund: Health Insurance and/or Prescription Insurance and/or Dental Insurance and/or Medicare Advantage/Employer

- Group Waiver Program as defined pursuant to N.J.S.A. 17B:17-4, the Fund's Bylaws, and Plan of Risk Management.
- iv.Adoption and approval of the Fund's Bylaws, a true and correct copy of which is annexed hereto as Attachment A, which has been approved by the Departments.
- v.Execution of the Local Unit's Indemnity and Trust Agreement, a true and correct copy of which is annexed hereto as <u>Attachment B</u>, which has been approved by the Departments.
- **BE IT FURTHER RESOLVED** that the governing body of the Local Unit certifies, pursuant to <u>N.J.A.C.</u> 11:15-3.3(a), that the Local Unit has never defaulted on claims under a self-insured plan and that it has not had its insurance canceled for nonpayment of premium for a period of at least two (2) years prior to this application.

- **WHEREAS**, the State of New Jersey is home to over 300,000 veterans, with approximately 65,000 residing in South Jersey—including Atlantic, Cape May, Cumberland, Gloucester, Salem, and parts of Camden counties—many of whom depend on the U.S. Department of Veterans Affairs (VA) for their healthcare needs; and
- **WHEREAS**, current Veteran Medical Centers offering extensive specialty care are in East Orange and Philadelphia, requiring veterans in South Jersey to travel considerable distances for access to specialists in cardiology, oncology, orthopedics, mental health services, physical rehabilitation, and advanced diagnostics; and
- **WHEREAS**, while Community-Based Outpatient Clinics (CBOCs) provide valuable primary care, they are not equipped to offer the full range of specialty services that aging and chronically ill veterans require; and
- **WHEREAS**, Hammonton, New Jersey, located centrally within South Jersey along major transportation corridors, such as the Atlantic City Express Way, the New Jersey Turnpike and the New Jersey Parkway has emerged as an ideal site for a new Veterans outpatient treatment facility due to its geographic accessibility to the Tri-State Area, community support, and infrastructure readiness; and
- **WHEREAS**, the Hammonton Town Council fully supports the establishment of this facility and will work on identified available land and interested private developers capable of facilitating the project; and

WHEREAS, the proposed project would also include a dedicated transportation hub designed to help veterans across South Jersey and the Tri-State area reach the facility conveniently and reliably, thereby removing a significant barrier to access for those with limited mobility or transportation options; and

WHEREAS, the establishment of such a facility will ensure that South Jersey veterans receive timely, equitable, and comprehensive care closer to home, in line with the nation's obligation to honor their service; now, therefore,

BE IT RESOLVED by the Senate and General Assembly of the State of New Jersey:

- 1. That this Legislature respectfully urges the United States Department of Veterans Affairs to authorize and construct an extensive outpatient treatment Veterans Medical Facility, including a supporting transportation hub, in Hammonton, New Jersey, to meet the long-standing and growing healthcare needs of veterans in South Jersey.
- 2. That this Legislature commends the Town Council of Hammonton for its leadership, vision, and commitment to serving the veteran community by offering land, community support, and developer interest to advance this project.
 - 4. That copies of this resolution be transmitted to the President of the United States, the Secretary of Veterans Affairs, the Majority and Minority Leaders of the United States Senate, the Speaker and Minority Leader of the United States House of Representatives, and each member of the New Jersey Congressional Delegation.
